- Visto lo Statuto del Politecnico di Torino emanato con D.R. 774 del 17 luglio 2019;
- Visto il Regolamento Didattico di Ateneo emanato con D.R. 650 del 20 giugno 2019;
- Considerata la Legge 6 novembre 2012, n. 190, recante "Disposizioni per la prevenzione e la repressione della corruzione e dell'illegalità nella pubblica amministrazione";
- Visto il Decreto legislativo 14 marzo 2013, n. 33, recante "Riordino della disciplina riguardante gli obblighi di pubblicità, trasparenza e diffusione di informazioni da parte delle pubbliche amministrazioni";
- Considerata la delibera del Consiglio di Amministrazione del 17 luglio 2019 nella quale è stata approvata la Convenzione con il Regolamento Generale allegato e di garantire la copertura finanziaria delle attività dell'Alta Scuola Politecnica a valere sull'avanzo vincolato;
- Vista la Convenzione triennale 2019-2022 dell'Alta Scuola Politecnica tra il Politecnico di Torino e il Politecnico di Milano che sancisce la collaborazione tra i due atenei nell'ambito della formazione di eccellenza che forma ogni anno 150 giovani talenti (60 al Politecnico di Torino e 90 al Politecnico di Milano), italiani e stranieri, selezionati tra i candidati iscritti ai programmi di laurea magistrale in Ingegneria, Architettura e Design al Politecnico di Milano e al Politecnico di Torino;
- Tenuto conto di quanto previsto all'art. 5 comma 5 lettera f) del Regolamento Generale ASP, in cui l'ammissione al programma ASP è subordinata ad un processo di selezione effettuato da apposita commissione nominata con decreto rettorale e prevede l'assegnazione di contributi economici a favore degli studenti partecipanti alle attività didattiche;
- Vista l'approvazione della Giunta dell'ASP in data 27 luglio 2020 del bando del Politecnico di Torino per l'ammissione alla Scuola e per la concessione dei supporti economici agli studenti che saranno ammessi al XVII ciclo dell'ASP (a.a. 2020/21)

DECRETA

Art. 1 Programme overview

Alta Scuola Politecnica (ASP), established as a joint venture between Politecnico di Torino (PoliTo) and Politecnico di Milano (PoliMi), is a school for high achieving students who have a passion for innovation and wish to develop their potential in a multidisciplinary community. ASP is an additional advanced programme for Engineers, Architects, Urban Planners and Designers, which runs parallel to the Master's degree programmes offered by PoliTo and PoliMi.

The ASP study plan consists of two basic elements: Courses and Multidisciplinary Projects.

The official ASP language is English.

ASP Courses are held in the form of one-week residential Intensive Schools taught by renowned professors from Italian and international institutions. Students attend a total of 4 ASP Courses over the two-year programme and study topics such as logic of modelling, creativity and sustainability, economics, management as well as ethical and socio-political aspects of innovation.

ASP activities for academic year 2020/21 will be adapted to the situation depending on the evolution of the COVID-19 health emergency.

ASP Multidisciplinary Projects are focused on real-world problems (e.g. infrastructures for high-speed trains, nanotechnology applications for healthcare, localization and design of congress centres, information systems for tracing hazardous materials, etc.) proposed by PoliMi and PoliTo faculty members in cooperation with businesses, public administrations and research institutions. Project teams are multidisciplinary and are composed of 6-8 students from different degree programmes, under the supervision of tutors selected from among the ASP faculty and the experts of the supporting institutions.

Each year ASP admits up to a maximum of 150 students, 90 at PoliMi and 60 at PoliTo.

The selection process is carried out separately at PoliMi and PoliTo. For this reason, applicants must apply for the ASP programme directly at the university where they intend to enrol.

Art. 2 Places available

Applications are invited for admissions to Alta Scuola Politecnica – academic year 2020/21.

Admissions are limited to **60 student places at Politecnico di Torino**.

Art. 3 Admission requirements

This Call for applications to ASP is only valid for students who enrol in a PoliTo Master's degree programme for academic year 2020/21 in first semester in compliance with the deadlines for enrolment in Master's degree programmes (see the Student Guide 2020/21).

International students taking part in exchange programmes can apply for the ASP programme only if they are enrolled in a 24-month double degree programme at Politecnico di Torino.



The admission requirements are the following:

1. Academic performance

All in-presence ASP teaching activities for academic year 2020/21 will be possibly granted or adapted to the situation depending on the evolution of the COVID-19 health emergency. Therefore, applicants are expected to attend all in-presence ASP teaching activities for academic year 2020/21.

For Italian university graduates

- A Bachelor's degree granting admission to a Master's degree programme at PoliTo, awarded before the deadline for enrolment in Master's degree programmes in first semester of academic year 2020/21 (see the Student Guide 2020/21). Students must have earned their Bachelor's degree on a standard timeline (3 years);
- A minimum weighted average grade of Bachelor's exams equal to or greater than 27.00/30 (calculated on all Bachelor's exam grades):

Weighted average grade: exam grades multiplied by course credits
$$\frac{(\text{Grade}_1 \times \text{Credits}_1) + (\text{Grade}_2 \times \text{Credits}_2) + \dots + (\text{Grade}_n \times \text{Credits}_n)}{(\text{Credits}_1 + \text{Credits}_2 + \dots + \text{Credits}_n)}$$

For non-Italian university graduates

- A Bachelor's degree - awarded by an accredited foreign university obtained after at least 15 years of previous education (primary and secondary plus university). In case you are enrolled in a "single cycle" Laurea magistrale course (5 or 6 years degree program) and you have not yet graduated, you must have completed at least 15 years of previous education (minimum 3 years at University level) having obtained at least 180 ECTS credits or equivalent - granting admission to a Master's degree programme at PoliTo in first semester of academic year 2020/21 in compliance with the deadlines for enrolment in Master's degree programmes (see the Student Guide 2020/21);
- Valid GRE® General Test (5 years since the test date) passed by the candidate before the application deadline.

Minimum scores in each test section:

- Verbal Reasoning: 156
- Quantitative Reasoning: 157
- Analytical Writing: 3.5

Applicants must have reached the minimum score in at least one of the three test sections.



2. English language certificate (B2 Level)

IELTS certificate (International English Language Testing System) – minimum score: 5.5

Certificates accepted or exemptions in substitution for IELTS minimum score: 5.5

Applicants with an Italian Bachelor's degree must refer to the following table "*Tabella transitoria adottata in data 04_12_2017_5.5_eng_def*"

Applicants with a non-Italian Bachelor's degree must refer to the following table "*Tabella adottata in data 23_09_2019_eng_def*"

All Applicants (both with Italian Bachelor's degree and with a non-Italian Bachelor's degree) can be exempted from having one of the above-listed certificates if they have a non-Italian qualification recognized by the Italian Ministry of Education and Research as equivalent to the Italian high school diploma (*diploma di maturità*), or else, if they have a higher qualification awarded by a higher education institution in which the medium of instruction is English, exclusively if based in: USA, UK, Canada, Ireland, Australia and New Zealand.

Important notice

Due to the COVID-19 health emergency, some English examinations have been temporarily suspended. Please check the deadline given by Politecnico di Torino in order to provide your English language certificate (<http://apply.polito.it/en/>).

Art. 4

Admissions and deadline

Applications are due on **23rd October 2020 at 12.00 (noon - Italian time - CET)** using the online application form (<http://apply.polito.it/>).

ASP students are selected from among the applicants who have successfully completed and submitted their application form through the Apply@poliTo platform – "Alta Scuola Politecnica Section".

Please note that applicants have to apply to a Master's degree programme for academic year 2020/21 before applying to Alta Scuola Politecnica.

Applicants are required to upload the following compulsory documents to their online application form, exclusively in English or Italian (please note that the motivation letter must be written in English):

- **for Italian university graduates and for non-Italian university graduates:**
 - English language certificate;
 - Motivation letter (in English)

- **for non-Italian university graduates:**
 - Valid GRE® General Test passed by the applicant before the application deadline (maximum 5 years since the test date). GRE certificates can be sent to Politecnico di Torino directly by the examination centre, as the university is an accredited ETS centre (select the code 6994). Politecnico is not responsible for any communication delays by ETS.



Art. 5 Selection process

After the application deadline, an Evaluation Committee (composed of ASP Board members appointed by the Rector of Politecnico di Torino) evaluates all the applications received.

The Evaluation Committee verifies if the applicants meet the academic requirements based on the documents attached to their application forms.

Applicants can be assigned up to a **maximum of 40 points** based on the following criteria:

- **Italian university graduates:** a maximum of 40 points for the average grade of all Bachelor's exams;
- **Non-Italian university graduates:** a maximum of 40 points for the GRE® General Test.

At the end of this process the Evaluation Committee will draw up the ranking list of first 120 admitted applicants to the second step of the selection process.

They will be invited to an interview in November 2020. The interview is held in English. If possible, applicants will undergo a face-to-face interview; otherwise, they will have a video interview depending on the evolution of the Covid-19 health emergency. Applicants are required to attend the interview on the date, time and place established by the Evaluation Committee. Failure to attend the interview entails the exclusion of the applicant from the selection process.

The list of applicants admitted to the interview and all the necessary information about the interview will be published on the "ASP interview" page (available at the following section <https://didattica.polito.it/asp/2021/>).

Applicants can be assigned a **maximum of 60 points** for their performance in the interview.

During the interview the Evaluation Committee will assess:

- communication skills;
- motivation and commitment to the programme;
- self-presentation;
- fluency in spoken English;
- successful completion of the "Percorso Giovani Talenti" project;
- content of the motivation letter.

Before the interview, applicants are invited to take a **non-compulsory psychometric test** which aims exclusively to improve the educational activities offered to our students. The test score will not count towards the overall score of the final ranking list of the students admitted to Alta Scuola Politecnica.

Art. 6 Selection outcomes

At the end of the selection process, the list of admitted students will be published on the "Selection outcomes" (available at the following section <https://didattica.polito.it/asp/2021/>) **no later than 4th December 2020**. Admission to the ASP programme is only valid for students enrolled in a PoliTo Master's degree programme for academic year 2020/21 in first semester in compliance with the deadlines for enrolment in Master's degree programmes (see the Student Guide 2020/21).



Admitted students are required to submit their acceptance letter **no later than 11th December 2020**. Failure to do so entails exclusion from the programme. The acceptance letter template must be downloaded from the "Selection outcomes" page.

Politecnico will also publish a "reserve list" on the "Selection outcomes" page. If an admitted student withdraws from the programme, applicants on the reserve list will be contacted by e-mail according to their position on the ranking list. In this case, they are required to submit their acceptance letter within two days of the communication by e-mail. Failure to do so entails the loss of the place in the programme.

Art. 7

Tuition fees and financial aid

1. All students who take part in the ASP programme and successfully meet the ASP curricular requirements are entitled to get a full tuition fee waiver (they do not have to pay any tuition fees due to Politecnico di Torino except for the regional tax and administrative fee which will amount to 161,00 euros for academic year 2020/21) for the two-year duration of their Master's degree programme;
2. ASP covers the living costs (transportation costs from Politecnico di Torino to the venues where ASP courses take place, lodgings and meals) of all students enrolled in the ASP programme at PoliTo during the Schools (whose location will be decided according to the evolution of the COVID-19 health emergency);
3. All students enrolled in the ASP programme at PoliTo receive some funds to carry out their Projects based on the ASP annual budget;
4. **Financial aid is offered only to international students (non-Italian citizens with a non-Italian Bachelor's degree)** who participate in the ASP programme at PoliTo. Financial aid consists of a grant of approximately 400.00€ net/month for the two-year period (24 months) of the ASP programme starting from January 2021 (more detailed information will be provided in due time). This scholarship is meant to partially cover students' living costs in Turin. In any case, students need to allocate some of their own funds to cover their living costs in Italy.

Important notice:

ASP benefits (see art. 7, section 1 and 4) cannot be combined with other sources of financial aid such as the Regional Agency for the Right to Education of Piedmont (EDISU), the Ministry of Foreign Affairs and International Cooperation (MAECI), the TOPoliTO scholarship, etc.

Other scholarships granted by internal or external institutions may not be compatible with ASP benefits. For further information, students should contact the institution in charge of granting the scholarships.

Students who do not successfully complete the ASP programme lose the aforementioned ASP benefits and must pay the tuition fees in full (this rule applies retroactively: students who lose their ASP status in second year must pay their tuition fees also for the first year). Students are required to pay their tuition fees according to the highest contribution level, unless they have previously applied for tuition fee reduction and have been assigned a lower contribution level.

For this reason, students are strongly encouraged to apply for tuition fee reduction.

All students are invited to read the Tuition Fee Guide for academic year 2020/21.



Art. 8 Competent office
