



*Special opening of the registration for admissions
to the bachelor's degree programme in Architecture - a.y. 2020/2021*

Rector's decree no. 772 dated 31 August 2020

THE RECTOR

- Having regard to the University Statute;
- Having regard to the University Teaching Regulations;
- Having regard to Decree-Law No. 6 of 23rd February 2020 on "Urgent measures on containment and management of the COVID-19 epidemiological emergency" and in particular Article 3, paragraph 1";
- Having regard to Ministerial Decree no. 215 of 12th June 2020, concerning "Definition of the number of places available for admission to single-cycle Bachelor's and Master's degree programmes for Architects 2020-2021" available on the MIUR website at this link [215 of 12th June 2020](#);
- Having regard to Ministerial Decree no. 216 of 12th June 2020, concerning "Procedures and contents of the admission tests for the single-cycle Bachelor's and Master's degree programmes for Architects (Italian and English languages) a.y. 2020-2021" available on the MIUR website at this link [216 of 12th June 2020](#);
- Having regard the Calls for applications for admissions to the Bachelor's degree programme in Architettura/Architecture a.y. 2020/2021 and its annexes and the Rector's decree no. 617 of 3rd July 2020 approved in the same Call;
- Having regard that the Call for admission mention the 28th of August 2020 at 12.00 p.m. as the deadline for the submissions of the applications, the 4th of September as the date of the test and the 10th of September as the date for the publication of the ranking list;
- Taken note of the received request on the 24th of August 2020 from Ms. XXX, that, following the presentation of medical certification, has reported the impossibility to participate to the admission test and consequently has asked to postpone the test itself;
- Considered acceptable her request, because of the particular situation of the candidate and considering that scheduling an extraordinary test a few days after the ordinary one indicated in the Call for Admission would not cause any violation of the par condicio of the other candidates, nor a unjustified increase of the administrative procedure according to the specific rules of the test (the tests through the appropriate computer application are different for each shift, composed of multiple choice questions and without any discretionary assessment when correcting the tests);
- Having regard to the need to ensure equal treatment to any additional candidates – that communicate the absolute impossibility, documented and certified by submitting the documentation to the Administration within the mandatory deadline of the 3rd of September 2020 at 12.00 p.m., to participate to the admission test on 4th of September 2020, for serious and justified reasons concerning health – granting them the possibility to participate to the extraordinary session, thus promoting the broadest participation to the selective procedure;
- Considering that the identification of the date of 8th of September p.v. to carry out the above-mentioned extraordinary session allows respecting the strict deadlines indicated in the Call for Admission, with particular reference to the publishing of the ranking list, to its updates and to the enrollment

DECREES

- To grant the request from Ms. XXX, because of the above-mentioned reasons, to fix an extraordinary session on September 8, 2020 at 9.30 a.m., to which any additional candidates who are unable to participate to the



ordinary session on 4th of September 2020 - for serious and justified reasons concerning health, documented and certified - can take part, in addition to the requesting candidate itself;

- To re-open the deadline for the registration to the test – only for the candidates that are in the above-mentioned conditions and who have requested it – from today's date and until 12.00 p.m. on Thursday 3rd of September 2020. Within the above-mentioned deadline, the interested candidates must provide the necessary medical documentation certifying the impossibility to participate to the session of September 4, 2020 by attaching it in the online registration process for the TIL test on the University platform called Apply@polito. This documentation will be evaluated from the Central TIL Committee appointed by the Rector. The result of the evaluation will be communicated to each candidate via e-mail before 7th of September 2020 at 12.00 p.m. If the Committee after the evaluation does not consider the documentation as serious health reasons that make impossible to participate to the ordinary session on September 4, 2020, the candidate will not have access to the extraordinary session. In this case, the candidate will not be entitled to any refund of the TIL-A test fee.
