Decree n. 617/2022

*New deadline for presenting
the Residence Permit – a.y. 2021/22*

THE RECTOR

- Having regard to Legislative Decree No. 33 of March 14, 2013, concerning "Reorganization of the discipline regarding the obligations of publicity, transparency and dissemination of information by public administrations" as amended and supplemented;
- Having regard to Law No. 190 of 6 November 2012, concerning "Provisions for the prevention and repression of corruption and illegality in public administrations" as amended and supplemented;
- Having regard to the University Statute;
- Having regard to the University Teaching Regulations;
- Having regard to the "Procedures for the entry, stay and enrolment of students applying for visas, related to courses of higher education in Italy, at institutions of higher education valid for the academic year 2021-2022" of 16 April 2021, which provide for enrolment with condition until June of the year following the year of application [...] if - even at the enrolment stage - the foreign student does not have a valid residence permit [...]" and that, no later than the same month of June, the Universities must verify the actual issuance of the residence permit;
- Having regard to the Calls for applications for admissions to the Bachelor's degree programmes and Professional Bachelor's degree programmes of Politecnico di Torino for academic year 2021/22 and the "Enrolment Regulations for academic year 2021/22" issued by Rector's decree no. 296/2021 - in particular art. 10- which recalls the aforementioned Procedures to identify the deadline by which foreign students must demonstrate to the University that they have a Residence Permit in order to drop the provisional condition pending on their enrolment, under penalty of cancellation of enrolment with resolute effect on any academic progress;
- Considering that many students, although with study visas, have reported their difficulty in obtaining their residence permit (Permesso di Soggiorno) by 30 June 2022, mainly due to the following two problems, which are not attributable to them:
 1. they arrived in Italy much later than the beginning of the academic year and the institutions in charge of issuing residence permits are delaying the issuance of these documents;
 2. although they have visas, they are blocked in the country of origin due to the restrictions still in force or suddenly introduced in the country related to the health emergency;

Having considered that, with an extension of the deadline to November 30, the above problems could reasonably be solved;

- Having consulted with the Vice Rector for Education and verified that such an extension will not affect the educational path of these students and, indeed, should enable them to continue their studies;
- Having regard to the communication Prof. 0027373 dated 17/06/2022 sent via certified e-mail to the Turin Police Headquarters (Questura di Torino) regarding the extension of the deadline to 30 November 2022;

DECREES

to extend to 30 November 2022 the deadline by which interested students must prove to the University that they have a residence permit in order drop the provisional condition pending on their enrolment.
